## NOTICE OF ANNUAL GENERAL AND SPECIAL MEETING OF SHAREHOLDERS

- 3. to appoint MNP LLP, as the auditor of the Corporation for the ensuing year and to authorize the directors of the Corporation to fix their remuneration;
- 4. to ratify and confirm the Corporation's Option Plan; and
- 5. to transact such further or other business as may properly come before the Meeting or any adjournment(s) or postponement(s) thereof.

Each person who is a holder of record of Shares at the close of business on August 14, 2017 will be entitled to receive notice of, and to attend and vote at the Meeting, or any adjournment or postponement thereof.

If you are unable to attend the Meeting in person, please exercise your right to vote by completing the enclosed form proxy and returning it to Computershare Trust Company of Canada, at 100 University Avenue, 8<sup>th</sup> Floor, Toronto, Ontario, Canada, M5J 2Y1, Attention: Proxy Department. In order to be valid for use at the Meeting, proxies must be received by September 12, 2017 at or prior to 4:00 pm (Toronto time), and if the Meeting is postponed or adjourned, no later than 48 hours prior to the commencement of recommencement of any adjourned or postponed Meeting.
